On January 4th until the 8th of 2013 we had a pre rally of Alfa See Ya's going to the FMCA Rally in Indio. There were 28 rigs. CORN CHOWDER Recipe from Lei.
Served during the November 2012 Outing

2 cups potato, cooked and diced
3/4 cup bacon, diced
3/4 cup onion, chopped
1 cup celery, diced
2 cans cream of chicken soup
2 cans whole kernel corn, drained
milk

Sauté onion, celery and bacon; leave celery slightly crisp. Add onion mixture and all other ingredients into crock pot. Add enough milk to make a hearty thick soup. Heat on medium until ingredients are warm and then turn crock pot down to low. Can cook on low all day.

Makes 8 servings

2 x recipe fills crock pot
4 x recipe for roaster oven.
These two together will feed 30+ people.

Report on the Jan 2013 Chapter Pre-Rally and FMCA Western Area Regional Rally

This year, we again we had our AlfaSeeYas pre-rally (prior to the FMCA Western Area Rally) at the Emerald Desert RV Resort in Palm Desert, CA. Our pre-rally ran from Fri Jan 4 to Tues Jan 8, 2013. Wagon master's Arnie and Emily Burr, along with great help from co-wagon master's Jack and Jane Stanley, did a great job of preparing, organizing, arranging, and ensuring we all had a good time! Everyone joined in to make it another very successful AlfaSeeYas function! Friday was arrival day – we had a total of 28 Alfas attend, as well as several more folks who joined us later in time to caravan. Friday night we had a catered dinner and introductions of all attendees.

Saturday morning we had our annual Chapter Business Meeting. We introduced the officers in attendance (myself, Terry Scott and Larry York) and Jean Maddux our newsletter editor. We presented a treasurer's report (our chapter is very healthy, as confirmed by the audit done in Oct 2012), introduced the four new chapter member families in attendance, and reviewed the year 2012 activities. Overall, we welcomed 32 new chapter members in 2012, while losing 18 (due primarily to those owners no longer owning an Alfa) for a total membership roster of 481 at the end of 2012. Our primary meeting agenda item was the election of chapter officers. We had received 73 ballots from our members - all of whom voted for the slate of officers as presented, with no names written in. At our meeting, the members voted to accept the slate as presented. As I mentioned in my President's message in this newsletter, thanks go out to all our current officers who agreed to serve another term, and thanks to the members who voted. As I also mentioned, while we all appreciate being elected again, we also believe that after having served 2 terms, it will be good to have other chapter members step in, so in about a year I will be asking for volunteers to serve on a nomination committee for chapter officers. I encourage you all to consider serving in an elected chapter position. At the end of our meeting, we had a drawing at which Doug and Marion Crocker won a pair of camping chairs and Mike Day won a first-aid kit (both gifts the chapter had received for having recruited new members).

After the business meeting, we had a question/answer session with Alfateers representatives Jon and Martin. As always, lots of good information was shared by all. One of the primary benefits of members getting together is the "cross-talk" of questions/answers and "how to" information amongst all Alfa owners!

During the pre-rally, we were provided with morning snacks and beverages, had our evening social hours, and had several enjoyable dinners provided by the RV resort. These included a Mexican dinner with entertainment (and dancing later) provided by a Mariachi band, and a "Smokin' Hot Hoedown" western dinner (at which folks could display their western wear too), along with dancing afterwards. We also had a coach walk one afternoon, and (as usual) we saw what others had done to personalize their Alfas, so we could "steal" their great ideas for our own coaches!

One evening, we had a presentation by a representative from SkyMed, at which several of us decided to sign up for their coverage plans. As I mentioned in previous newsletters, with the

advent of all the FMCA Assist coverage no longer being supplied at no charge, it behooves us all to look in to all avenues of coverage. SkyMed makes presentations and/or has an information booth at a number of RV events, and I would encourage you to listen to them - as well as those of other similar insurance companies - and decide for yourself if this type of coverage is for you.

Tuesday morning "bright and early" (at 7:30 am!) we lined up our coaches on the nearby street, and caravanned to the FMCA Western Area Rally site at the nearby Indio fairgrounds. Arnie had done a great job of preparing maps and briefing everyone, so we all got there on time and in a group, plus several others who joined up with us. We had a total of 21 RVs, and were able to park together - to include an area for our evening social hours. By arriving at Indio a day early, in addition to getting a good area to park in, we were able to get all our registration materials well in advance to start planning what rally activities and events we wanted to attend. As we had done last year, we asked our chapter attendees if they would like to volunteer to help at the Western Area Rally (all of these types of rallies are put on primarily by volunteers) - and we had 20 of our folks do so. We attended a volunteer meeting that afternoon and a volunteer dinner that night, and then acted as seminar monitors (for about 3-4 seminars each) along with several other chapters during the rally. It was fun, did not take a lot of time, and felt good to help out. The FMCA Rallies are always a lot of fun, with many activities, seminars and entertainment scheduled. Each afternoon, we AlfaSeeYas had an informal social hour in the area near our coaches, with many tasty snacks provided by all. Since we had some funds left over from the pre-rally, we all enjoyed pizza one night too!

Again, thanks so much to the Burrs and Stanley's for putting on another great pre-rally! Prior to departing, we signed an agreement with the Emerald Desert RV Resort to hold our pre-rally there again next year. We were very fortunate in having Larry and Shirley York volunteer to be wagon masters for next year's pre-rally, and Dale and Diana Manners volunteer to be co-wagon masters! I also need some recipes to put in the newsletter. Any kind of recipe would be good as long as it is easy and can be done in a motor home. Appetizers are always a good thing for serving at 'Happy Hours'.

PLEASE, PLEASE send me some stories and recipes !!!

Randy Scott submitted the following recipe. He says his dog really likes them. The only thing he did differently is once they were cooked per the recipe, they were still a bit moist, so put them in a dehydrator to fully dry them out so they would last longer. One could put them in a low temp oven as an alternative. **This recipe is from the American Kennel Club.**

Special Dog Biscuits Pumpkin Peanut Butter Biscuits

- 2 $\frac{1}{2}$ Cups whole wheat or barley flour
 - 2 Eggs
 - 1 Cup canned pumpkin
 - 3 Tablespoons peanut butter
 - $\frac{1}{2}$ Teaspoon cinnamon
1. Preheat oven to 350 degrees
 2. Stir dry ingredients in a medium bowl, in separate bowl whisk together eggs, pumpkin and peanut butter. Add egg mixture to flour mixture and knead thoroughly. Dough should be dry and stiff, add small amounts of water as needed to make it workable. If dough is too sticky, add small amounts of flour. Roll dough into half- inch pieces, using a knife or cookie cutters.
 3. Bake about 40 minutes, or until hard and dry.

An exciting 10 day rally visiting two of the most sought after venues in Pennsylvania. Please see the Registration Form for costs and itinerary.

We start our tour with a 4 day visit to Gettysburg. The Battle of Gettysburg was fought July 1–3, 1863, in and around the town of [Gettysburg, Pennsylvania](#). The battle with the largest number of casualties in the [American Civil War](#); it is often described as the war's [turning point](#). [Union Maj. Gen. George Gordon Meade's Army of the Potomac](#) defeated attacks by [Confederate Gen. Robert E. Lee's Army of Northern Virginia](#), ending Lee's invasion of the North. Along with visiting the Gettysburg National Military Park Museum and Visitor center, we will also have an optional full day guided tour of the battlefields, the Shriver Home, and end with dinner with "General and Mrs. Lee". See <http://www.nps.gov/gett/index.htm> for information on other activities provided by the Visitor Center.

We will then move to Lancaster for a 6 day, 5 night stay among the Amish. The farmlands of the Pennsylvania Dutch Country are among the most productive in the nation. But many of the farmers here are different from most Americans; different by choice. For these are the Old Order Amish and Mennonites, also known as the "Plain People".

Our Amish neighbors have been employing horse-drawn power since the days when horsepower had a whole different meaning! In comparison to our fast-paced society, the simpler, family-centered Amish way of life holds a special fascination. Fought over the first three days of July 1863, the Battle of Gettysburg was one of the most critical battles of the Civil War having occurred at a time when the fate of the nation hung in the balance - the summer of 1863. Often referred to as the "High Water Mark of the

Confederacy", it was the culmination of the second and most ambitious invasion of the North by General Robert E. Lee and the "Army of Northern Virginia". The "Army of the Potomac", the Union army that had long been the nemesis of Lee, met the Confederate invasion at the crossroads town of Gettysburg and though it was under a new commander, General George Gordon Meade, the northerners fought with a desperation born of defending their home territory. The Union victory at the Battle of Gettysburg resulted in Lee's retreat to Virginia and an end to the hopes of the Confederacy for independence.

4:00 pm Tour of the **Shriver Home**

In Gettysburg, Adams County there is the famous battlefield with intact cannons, large cemeteries with hundreds of aged tombstones, and a main road lined with houses in narrow lots. The houses look as though they've been standing since the late 1700s, but most of them are a façade, having actually been built well after the Civil War. The oldest house on the town's main street, Baltimore Street, was built in 1860, only a year before one of the bloodiest battles on United States soil began. It is known as The Shriver House and is now an award-winning historic museum, owned by Nancie and Del Gudmestad. The couple's restoration of the Shriver House has been so thorough that even television specials such as "The Shriver's Story," "If Walls Could Talk," and "Most Haunted Live: Gettysburg" have taken note, traveling to Gettysburg to document the museum and interview the owners. The mission of the museum is to provide the "Civilian's Experience" of what is considered the bloodiest battle fought on U.S. soil; an experience that Nancie Gudmestad believes is "overlooked by historians and interpreters of the encounter."

George Washington Shriver bought a double-lot of land on the edge of Gettysburg in 1860, and quickly started building a home for his family. It was quite a large house, especially in that day and age. It had a parlor, used only for special occasions, and a sitting room, more like a contemporary family room. This is where daughters Mollie and Sadie completed their homework, but also where the family meals were served. Shriver built his wife, Hettie, a rather large kitchen right behind the sitting room. The house had two bedrooms, one for his daughters and the other for him and his wife. There was also a workroom, which served as a closet. Hettie's sewing machine and materials were kept in that room, as well as a small desk and several books. Upstairs was a large garret meant for additional storage.

Because he planned to start a business of his own, Shriver built a tavern in the basement of the house. He included a separate kitchen in the cellar meant to be used to prepare meals for the saloon. After the house was completed, he built a 16-by-64 foot building behind the house. In it, he constructed two ten-pin bowling lanes. Additionally, there was a garden in the backyard, where Hettie and her daughters would grow and harvest crops year round.

Both Shriver and his wife grew up on small farms just outside of Gettysburg. Mr. Shriver bought the double-lot of land on South Baltimore Hill for just \$290 in 1860 with the intentions of building a nice, upper-class home for his wife and their two daughters. At the time, Mollie was five years old, and Sadie was three. In April 1861, as they were putting the finishing touches on their new home, the Civil War began.

Initially, many Americans did not believe the war would last, but that following September, President Lincoln called for 75,000 more troops. Mr. Shriver decided to enlist. By the winter of 1862, Mrs. Shriver and the girls had become used to having many Union soldiers spending their nights in the saloon and bowling alley, but Mr. Shriver never did. Then in 1863, two years after the beginning of the war, Confederate troops crossed the Mason

Dixon Line into Pennsylvania. On July 1, the Battle of Gettysburg began. Mrs. Shriver decided to take her two children to her parents' farm just three miles south of town, hoping for safety. Unfortunately, that farm was located right in between Big Round Top and Little Round Top, where some of the most severe fighting took place.

Over the next three days, there was very little communication between family members due to cannons and gunfire. When the fighting ended, there were wounded and dead men and horses all around the farm. Mrs. Shriver stayed a few days to help care for the wounded soldiers and bury the dead. The Battle of Gettysburg left 52,000 men and 5000 horses dead. On July 7, Mrs. Shriver decided to take her daughters home.

Unfortunately, most of their little town had been destroyed. It was almost unrecognizable. Most of the houses around hers were in ruins, yet the Shriver house stood strong. She learned from neighbors that the Confederate soldiers had occupied her home and had set up a sharp-shooter area in her attic. It was known that at least two soldiers had been killed there. She also found huge holes in the side of her house where they had sniped passing Union soldiers. Mrs. Shriver worked vigorously to make her house a home again, but without George, the task seemed in vain.

Five months later, George Shriver was granted a four day furlough to spend Christmas with his family. The reunion was not a happy one, for the war and the two and a half years apart had changed them all, especially Mr. Shriver. He reported back for duty on December 29, 1863 to Cole's Cavalry. The cavalry, consisting of only 250 men, was attacked by more than 400 Confederate soldiers. In the end, Cole's Cavalry suffered three casualties and six wounded men. George Shriver and six fellow soldiers were taken prisoner on January 1, 1864.

George Shriver was held prisoner at the notoriously cruel and deadly Andersonville Prison in Georgia until his death in December 1864. On April 1, 1866, financial concerns forced Hettie Shriver to sell her house for \$2,100 to Daniel Trimmers. She and her two daughters moved to High Street in Gettysburg.

The house had mostly been conserved, until the new owners decided to split the house into a duplex with several apartments on each side of the building in 1905. The bowling alley was torn down, and additions were built attached to the back of the original house. The changes in the building have made the structure vulnerable. Over the years, different owners added new stairways, windows, and entryways. One owner even placed heavy heating furnaces on the second floor, a foundation clearly never meant to support that sort of permanent weight. Beginning in 1967, the house was left vacant for nearly 30 years. The Borough of Gettysburg tried several times to condemn the property, but local citizens wouldn't allow it.

In 1996, the Shriver House was bought by the Gudmestads. They immediately began restoration on the property with intention to get it back to its original appearance. Almost immediately the Gudmestads started finding special artifacts from the 1860s. In the attic, there were Confederate bullets found, some that had not been used and some that had. Additionally, Union bullets were removed from the bricks in the garret and medical equipment was found under the floorboards. In the house, a little girl's shoe believed to be one of George Shriver's daughter's was found in a wall. Other household items were found,

for example, a jello cookbook, glassware, and spectacles. These objects were able to help tell the story of the family that lived here, and the time period. But the biggest discovery, according to the Gudmestads, was not found in the house. It was the diary of the Shriver's neighbor, Tillie Pierce. This diary gave a detailed description of the Shriver family and what occurred during the days when the Civil War came to Gettysburg.

The Gudmestad's have taken on Mr. Shriver's task, spending several years restoring the house and replacing the little bits and pieces that would make this a home of the late 19th century. In each room there are details of the time, such as a wooden butter churn in the kitchen, or classic tea cups and antique jacks set in the girl's bedroom. With the tour guides in full time period dress, the entire experience at the museum is dedicated to bringing visitors back to the 1860s. The guides give an intimate portrayal of the Shriver family, making the tour not an average boring museum tour, but a more accurate invitation into a friendly neighbor's home.
